




CALIFORNIA HIGH-SPEED RAIL: IT'S HAPPENING!

Governor Newsom's commitment:

• "... we will continue our regional projects north and south. We'll finish Phase 1 environmental work. We'll connect the revitalized Central Valley to other parts of the state, and continue to push for more federal funding and private dollars" (February 2019 State of the State address)





PROGRAM COMMITMENTS

- Meet our Federal Railroad Administration (FRA)/American Recovery and Reinvestment Act (ARRA) Grant December 2022 deadline
 - » Central Valley Segment 119 miles (Madera to Poplar Ave.)
 - » Align to 2019 Updated Baseline (\$15.6B)
 - » May 2019 Board Meeting: Budget approved in Updated Baseline for Segment 1
 - » Merced-Fresno-Bakersfield is the first step towards Valley to Valley
 - » Match available funds to doable projects
 - » Connect to high-ridership regional transit systems
 - » Refocusing delivery around "building block" approach

Total Investment

- \$900 million from HSR
- \$4.4 billion in state funding
- Enables \$16.8 billion

HSR Investment

- \$420 million to LA Metro/Link US
- \$130 million to PTC
- \$89 million to Metrolink Tier IV locomotives
- \$75 million for Rosecrans/Marquardt
- \$110 million Regional Connector
