Iconic Facility


- Opened in 1968 with 2500 seats

Brief Project History


- Previous Facility Closed in 2013 due to seismic concerns
- Constructed existing pool in 2014
- Previous facility demolished in 2014
- Draft EIR Certified in 2016
- Original project submitted to CCC in 2018
- Revised project approved by CCC in 2021




Current Project Status

- Contractor Prequalification RFQ to be released shortly


Project Location



Aerial View of Site




Project Overview Plan




OVERALL ARCHITECTURAL PLAN



- Relevant ICC, ACIA, APWA CPII, QSP, OSHA 30 certifications are desirable

GC RFQ - Overview

- Formal prequalification process pursuant to Public Code Section 20101
- Prospective bidder qualifications will be evaluated in accordance with the State of California
 Department of Industrial Relations "Labor Commissioner's Model Questionnaire", dated March 19,
 2019, as adapted for the merits of the project
- Anticipated minimum qualifications:
 - Prior performance as prime contractor on at least five Projects over the past ten years with \$50M+ valuation.
 - Prior performance as prime contractor, and satisfactory completion on a minimum of (3) projects with scope of work predicated on pools/aquatics center (municipal or private)
- Only prequalified prospective bidders will be eligible to bid on the project
