



# I-405 DESIGN BUILD MULTI-ASSET FROM I-5 TO HARBOR BLVD





#### Scope

The project propose to address both roadway and traffic management system (TMS) improvements. The work involves:

- 1. Pavement Rehabilitation
- 2. Replace bridge approach & departure slabs.
- 3. Improve planting and irrigation system.
- 4. Relocate maintenance facilities and improve workers safety.
- 5. Improve lighting.
- 6. Install cameras and smart lighting.
- 7. Widen on ramps, add auxiliary lanes and Park & Ride.
- 8. Upgrade guard rails and bridge rails.

Construction Capital: \$164 million
Total: \$205 million
