



Alvord Unified School District (USD) – Measure J Bond Program: Enhancing Infrastructure and Identity

Introduction

The Alvord USD Measure J Bond, a \$248 million initiative, is transforming the district's schools through a series of essential modernization and improvement projects. These efforts focus on enhancing safety, security, aesthetics, and the overall learning environment for students and staff. As of October 2024, the bond program has completed 17% of its total scope, with 58% of the Series 1 bond funds already allocated. This document provides an overview of key ongoing projects and strategic initiatives, including the district's emphasis on branding and community engagement.

Series 1 Bond Overview

• Total Series 1 Bond Amount: \$78 million

• Funds Spent to Date: 58%

• **Project Categories**: Infrastructure upgrades, safety improvements, modernization projects, and aesthetic enhancements across multiple schools.

Key Series 1 Projects

Middle School Hardcourt Improvements:

Schedule: October 2025 – March 2026

Project Cost: \$3 million

Expected Scope: Removal and replacement of hardcourt areas at Arizona,
 Villegas, Loma Vista, and Wells Middle Schools. This involves removing old
 asphalt, preparing the underlying ground, and installing new hardcourt surfaces
 to ensure safety and durability.

Middle School Exterior Paint:

• Schedule: July - December 2025

Project Cost: \$3 million

• **Expected Scope**: Exterior painting of buildings at Wells, Arizona, Villegas, and Loma Vista Middle Schools. This includes surface preparation, priming, and applying high-quality paint to protect the buildings and enhance their aesthetic appeal.

La Sierra High School - Track and Field Modernization:

• **Schedule**: June 2025 – June 2026

Project Cost: \$12 million

Expected Scope: Complete removal and replacement of the track and field.
 Installation of a modern rubberized track surface, synthetic turf, new bleacher seating, a press box, and stadium lighting. Underground pathways will be added for future infrastructure needs like electrical and low-voltage systems.



La Sierra High School - Portable Removal:

• **Schedule**: June – August 2025

• **Project Cost**: \$500,000

• **Expected Scope**: Removal of 11 portable buildings, including restoring the ground with new asphalt to ensure a durable, safe surface.

La Granada Elementary School - MPR Modernization:

• **Schedule**: April – October 2026

Project Cost: \$2 million

• **Expected Scope**: Renovation of the Multi-Purpose Room (MPR). Scope pending architectural review but may include structural, mechanical, and aesthetic enhancements.

Alvord High School Parking Lot Addition:

• Schedule: December 2025 - March 2026

• Project Cost: \$1 million

• **Expected Scope**: Addition of a new parking lot to alleviate congestion and improve accessibility. Includes site preparation, grading, installation of high-quality asphalt, and installation of an electronic gate controller and badge access system for enhanced safety.

Loma Vista Middle School Admin Relocation Project:

• Schedule: October 2025 – April 2026

Project Cost: \$5 million

• **Expected Scope**: Relocation of administrative offices to the existing workout classroom and attached office spaces. Involves modernization to meet functional needs and renovation of the current administration space to improve efficiency.

Series 2 Bond Sale

• Amount: \$46 million

• **Expected Timeline**: 2026 – 2028

Series 3 Bond Sale

• Amount: \$62 million

• **Expected Timeline**: 2028 – 2030

• **Expected Timeline**: 2030 – 2032
