Next 10 Delivery Plan Update



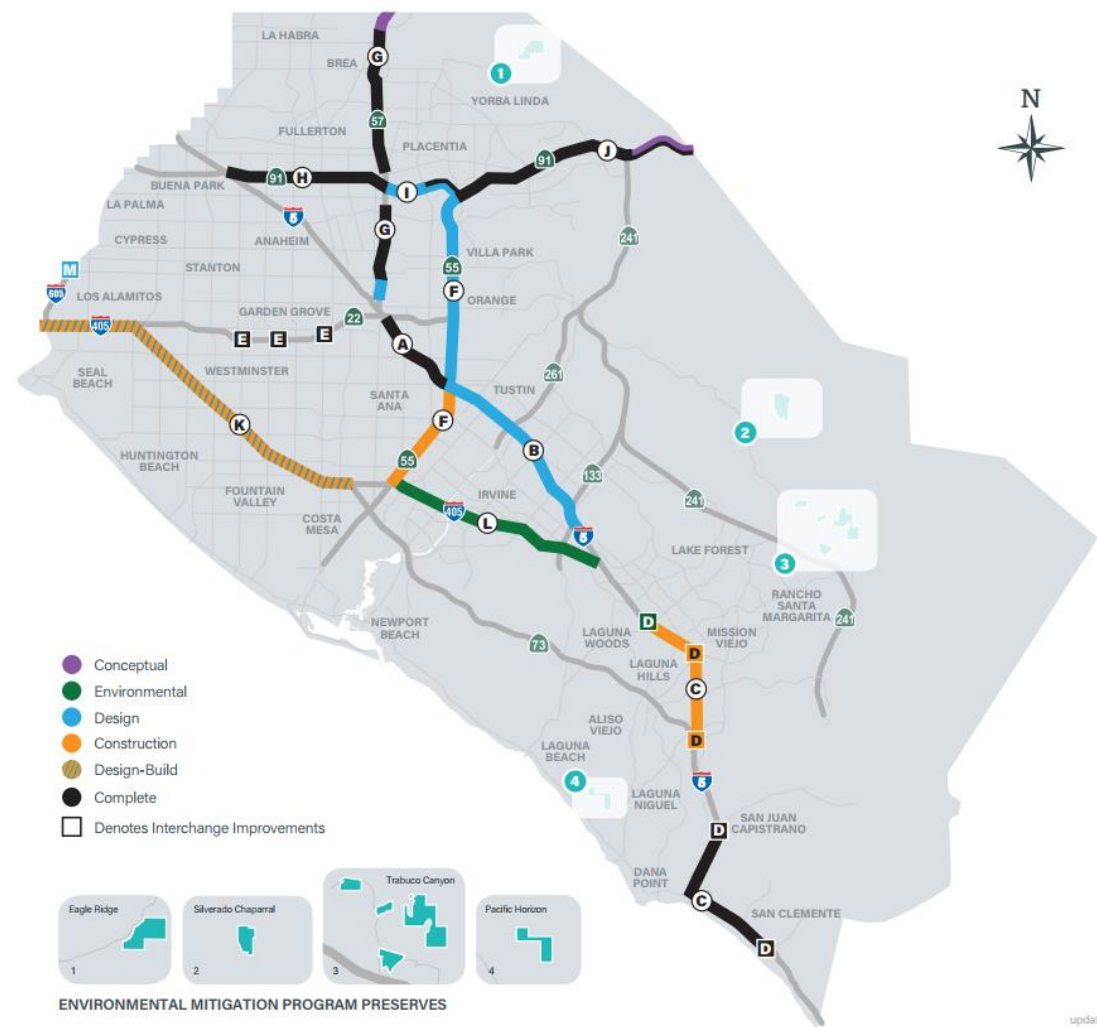
- Next 10 Plan updated in 2023 (ten-year plan)
 - Matches delivery plan schedule and cost with forecast revenue
 - Updated annually
- Revenue - 2024 M2 revenue forecast is \$14 B (vs. \$14.8 B in 2023)
 - Most areas of M2 Plan scale to available revenue
 - Freeway Program generally not scalable due to general scopes in ordinance
- Cost estimate and schedule updates on freeway and transit projects
 - Escalation rates
- M2 revenue forecast slightly down ↓ by \$800 million
- Cost escalation up ↑ 2% to 6% near term (Sept. 2024 OCBC forecast)
- Reservation for economic uncertainty

- A total of 5% of OC Go Freeway Program funds is allocated to the Freeway Environmental Mitigation Program
- A total of 2% of the overall OC Go Program funds is allocated to the Environmental Cleanup Program

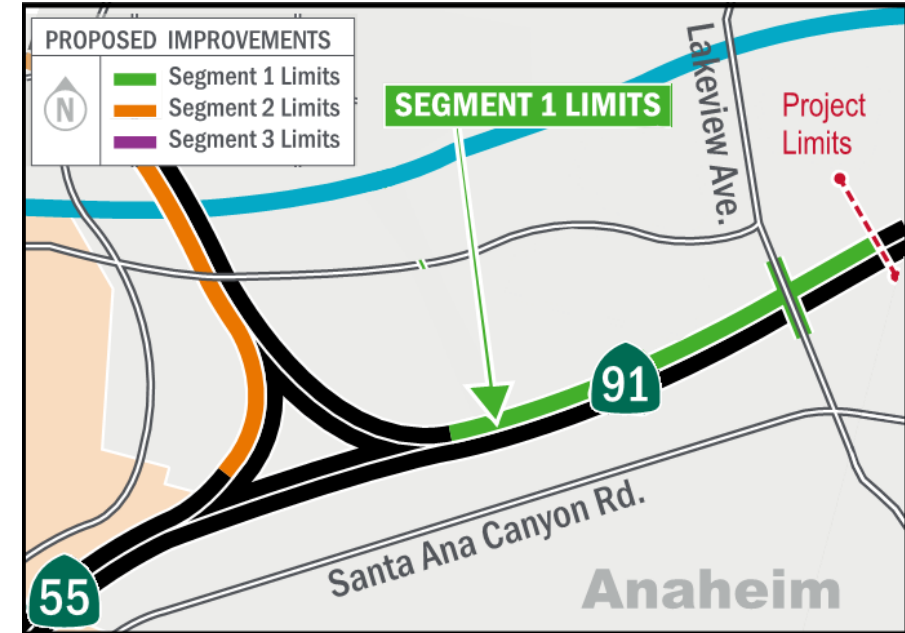

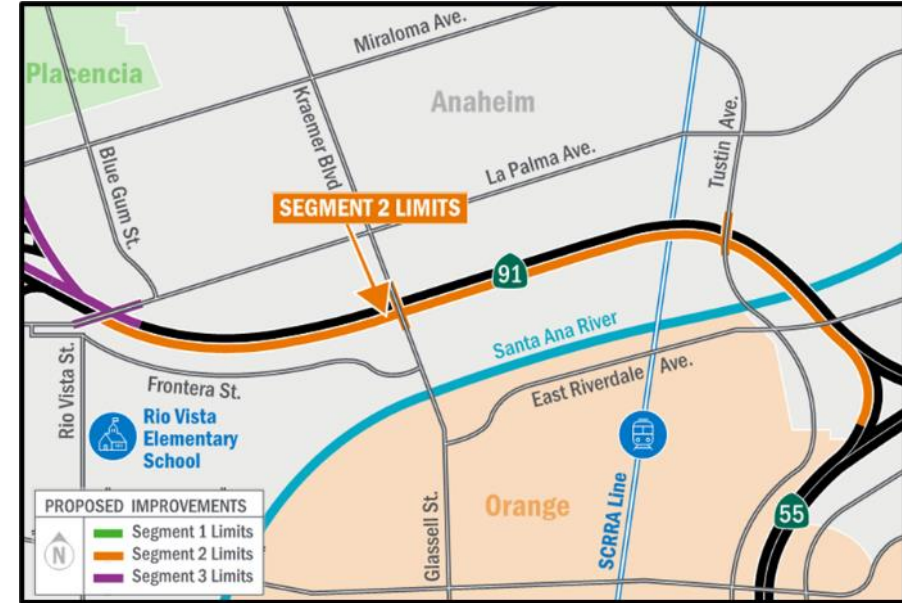

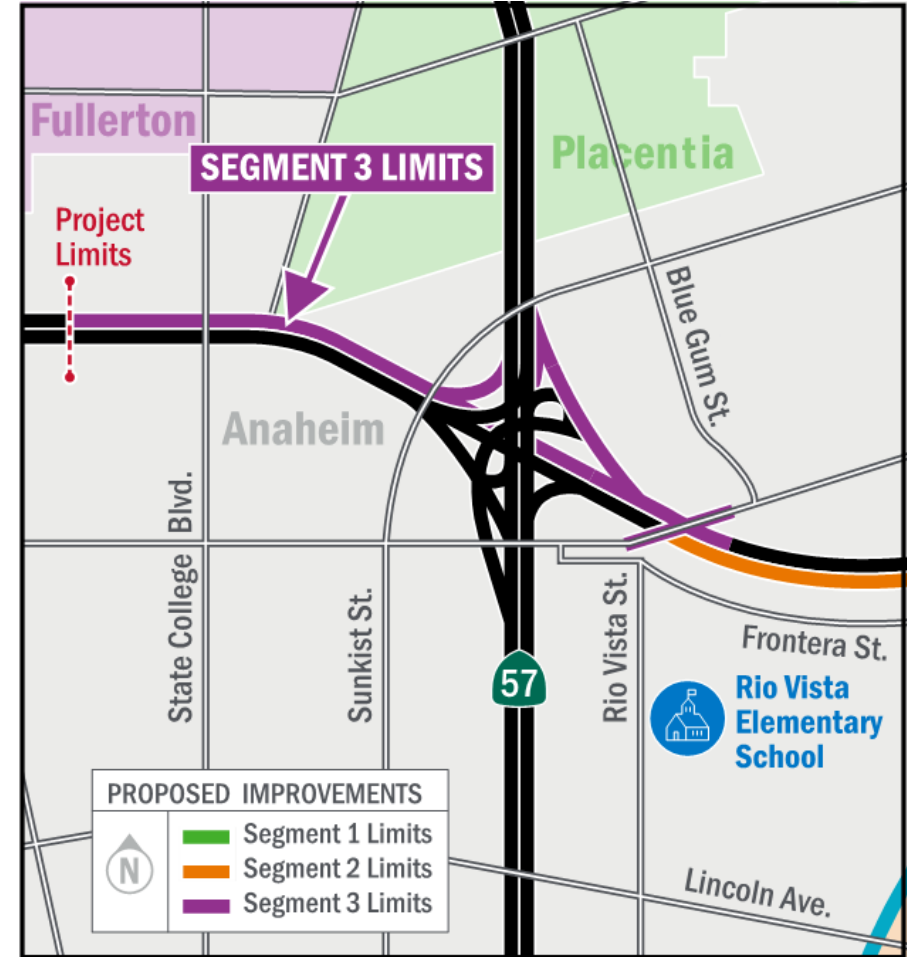

SR-91 (Acacia Street to La Palma Avenue)

 - Improves weaving from westbound SR-91 to SR-57
 - Add an auxiliary lane from WB SR-91/ NB SR-57 to State College Boulevard
 - Replaces La Palma Avenue overcrossing

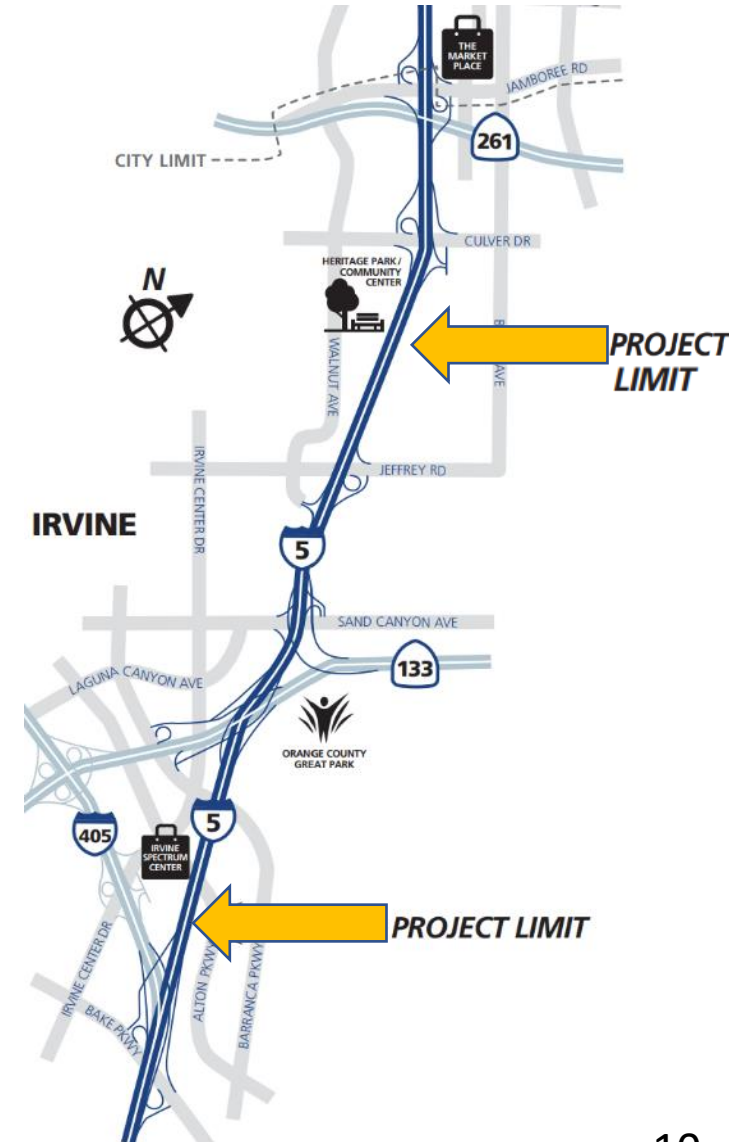

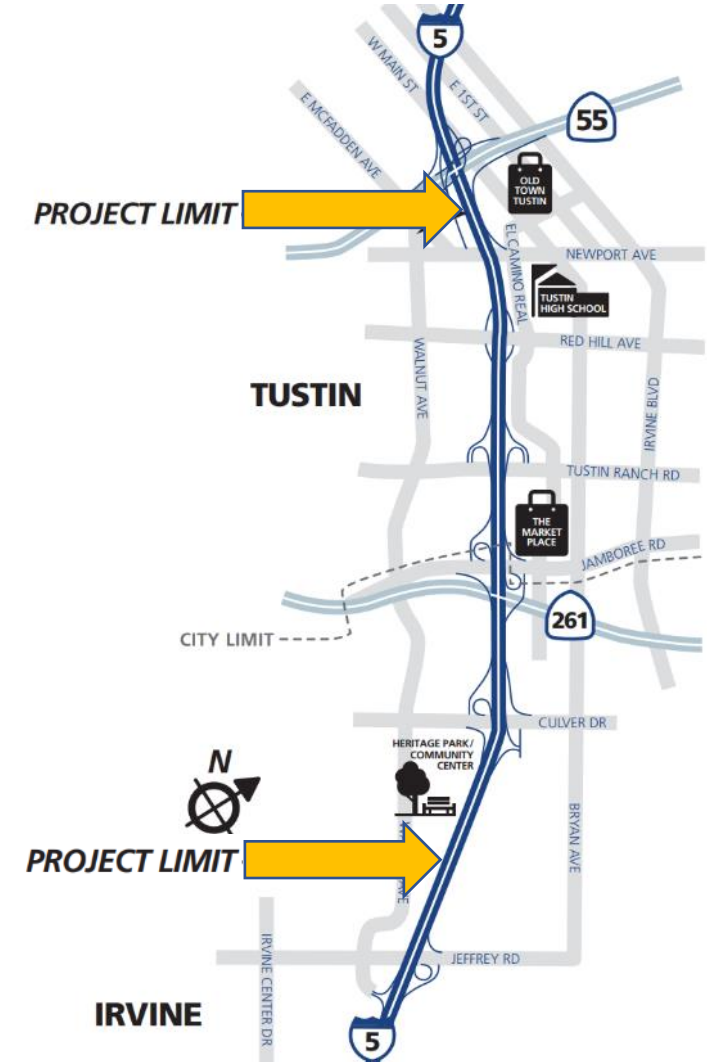

Northbound SR-57 (Orangewood to Katella)

- Scope – 1 mile
 - Extends fifth general purpose lane
 - Retains auxiliary lane between Orangewood and Katella
 - Improves on- and off-ramps
 - Improves merge movements
 - Length: 1 mile
- **Construction ~ \$90 million**

SR-55 (I-5 to SR-91)

- Scope

- Adds one lane in each direction between I-5 and SR-22
- Improves off-ramps at Fourth Street and southbound Katella Avenue off-ramp
- Relocates southbound Lincoln Avenue/Tustin Street off-ramp

- **Construction ~ \$105 million**

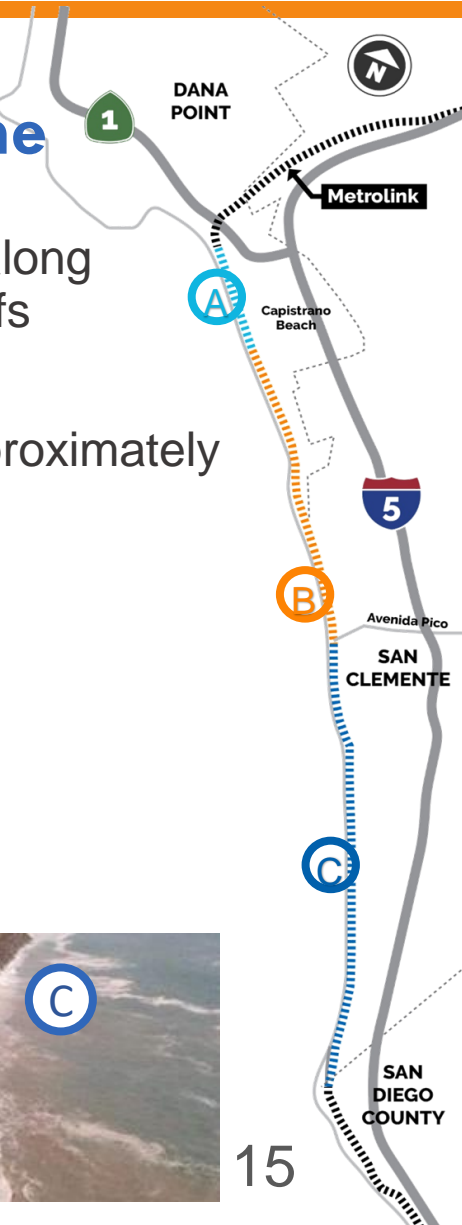
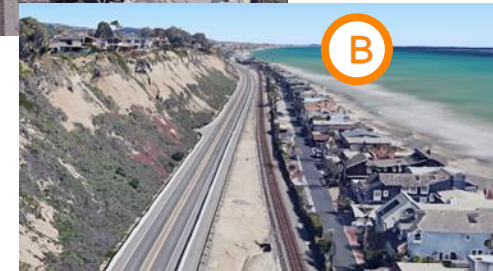

Phase I Study Underway

short- to medium-term solutions

- Develop options to protect coastal rail infrastructure at various sea levels
- Gain an understanding of climate effects on coastal rail infrastructure
- Identify potential solutions for sand replenishment / retention
- Identify vulnerable areas to take speedy action
- Consult and engage key stakeholders / agencies
- Study cost: ~\$2 million
- Probable capital costs: ~\$ millions TBD

Phase II Study

long-term solutions

- Develop options for potential long-term solutions for the coastal section of rail line
- Create an action plan for key elements
- Partner with LOSSAN, state and federal agencies
- Consult and engage key stakeholder / agencies
- Study cost: ~\$5 million*
- Probable capital costs: ~\$ billions TBD

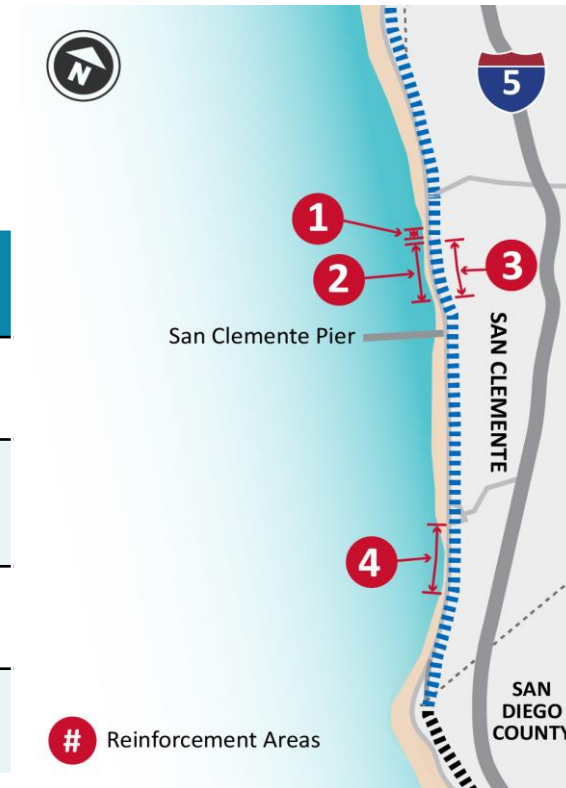
Coastal Rail Resiliency Study – Immediate Needs



- Four reinforcement areas were identified in January 2024
- Potential solutions evaluated at a conceptual level considering different materials, performance, costs, methods, and schedule

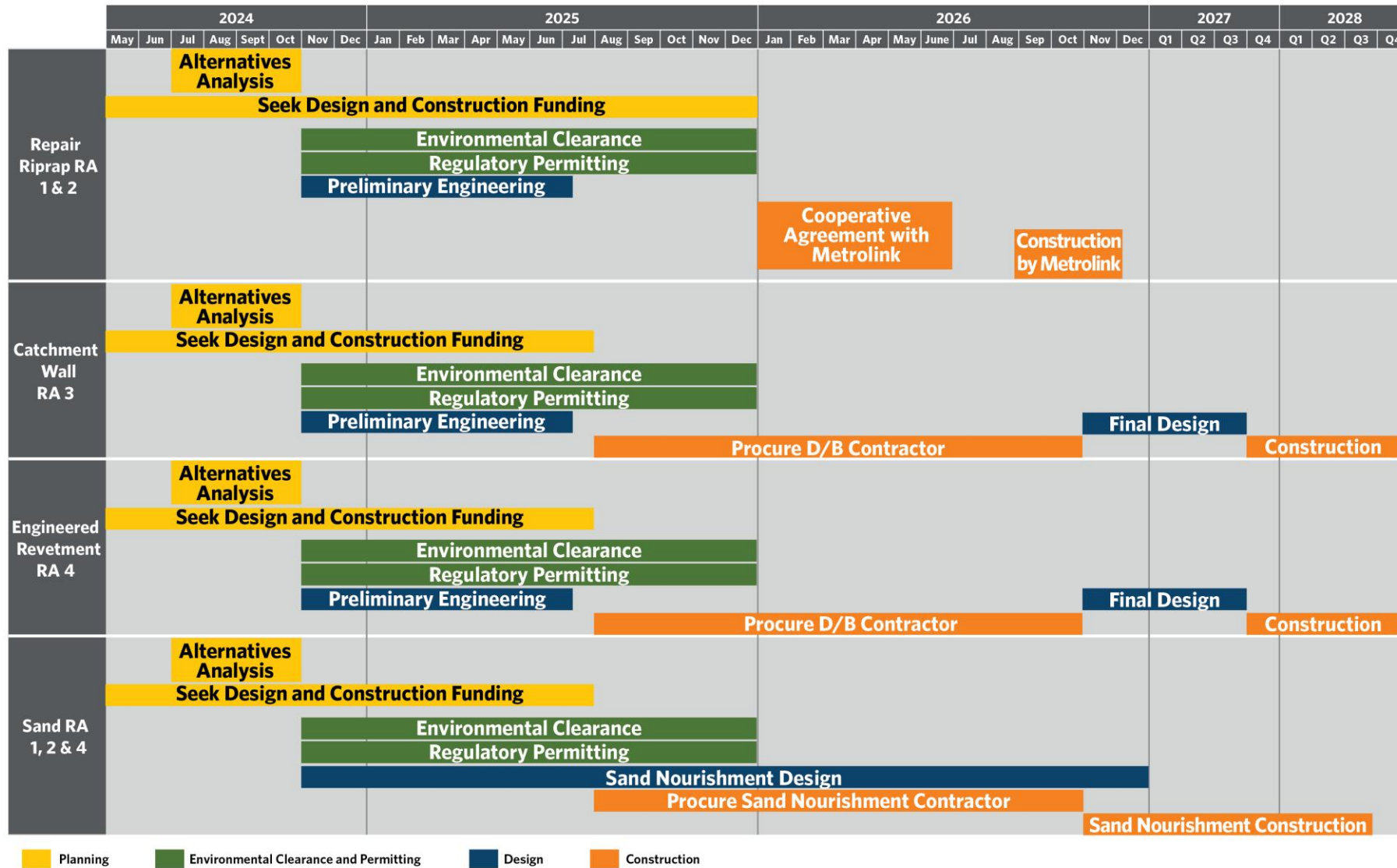

Debriefing For Unsuccessful Proposers or Bidders

Request a Debriefing, ask questions that will help your success on the next pursuit:


- Was the proposal/bid compliant to the requirements, if no can you elaborate what steps needed to be taken to remedy?
- What were our major strengths and deficiencies? How competitive were we on price?
- What did we do right? What could we have done better?
- Did our resume format work for the evaluators?
 - Request the successful firm's proposal/bid through a public records request.
 - Review their approach, resumes and projects. Does your firm's technical proposal and resumes include all relevant experience? Are there strategies to completing the work that you have not considered? Start updating!
 - If you're a Small or DBE firm, contact the successful Prime with a phone call and/or e-mail. Include a summary of qualifications and pertinent team resumes. Let them know you reviewed the RFP/IFB closely, are ready to work and can assist them with increasing their small or disadvantaged business participation, if needed.

Placed On A Team but They Were Not Successful?

Reach Out:

- Request the successful team's proposal/bid through a public records request
- Was a vendor listed for the scope your firm performs?
- If no, contact the Prime with a phone call and/or e-mail. Include a summary of your qualifications and pertinent team resumes. Let them know you were on a team for this solicitation, reviewed the RFP/IFB closely and are ready to work and can assist them with increasing their small or disadvantaged business participation.
- If yes, review their approach, resumes and projects. Does your firm's summary of qualifications and resumes include all relevant experience? Are there strategies to completing the work that you have not considered? Start updating! Reach out to the Prime in case something falls through or if you can provide an additional service not proposed.

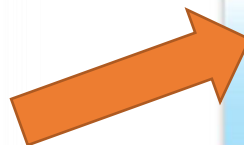
